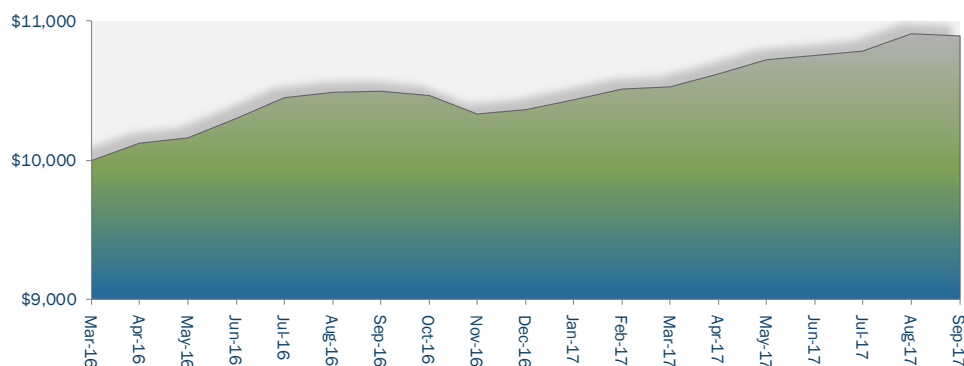
Investment Strategy

The Wilshire Income Opportunities Fund's (the "Fund") primary investment objective is to maximize current income. Long term appreciation is a secondary objective. The Fund seeks current income through a diversified, multi-sector portfolio of U.S. and international high yield and investment grade debt securities. The Fund's underlying subadvisors actively allocate to a broad spectrum of fixed-income securities with varying maturities seeking to manage risk, enhance yield, and offer total return potential.

Wilshire Associates Incorporated, the Fund's investment advisor ("Advisor"), has entered into a contractual agreement to limit expenses to 1.15% and 0.90% of average daily net assets for Investment Class Shares and Institutional Class Shares, respectively, through April 30, 2018. This agreement does not include taxes, brokerage expenses, dividend expenses on short securities and extra ordinary expense. To the extent that the Fund's expenses are less than the expense limitation, Wilshire may recoup the amount of any management fee waived/expenses reimbursed within three years after the year in which Wilshire incurred the expense if the recoupment does not exceed the existing expense limitation as well as the expense limitation that was in place at the time of the fee waiver/expense reimbursement.

Duration is a measure of volatility not time that is used to determine the price sensitivity of the security for a given change in interest rates. Specifically, duration is the change in the value of a debt security that will result from a 1% change in interest rates, and generally is stated in years.
